

Privacy Policy Statement

Updated on 12 October 2020

Definitions

In this Privacy Policy Statement:

“Infinitus” refers to Infinitus Health Products (International) Company Limited and its associated and affiliated companies. “Infinitus”, “we”, “us” and “our” can be used interchangeably.

“Website” refers to www.infinitus-int.com. “Website” and “www.infinitus-int.com” can be used interchangeably.

“User” and “you” refers to the person(s) or organization(s) that access(es) to and/or use(s) the Website. “User”, “User’s”, “you” and “your” can be used interchangeably.

“Business Partner(s)” and “Partner(s)” refer to other person(s) or organization(s) that has/have business connections with the Website.

I. Personal Data Protection

1. Infinitus respects and is committed to protecting your privacy by complying with the requirements of the Personal Data (Privacy) Ordinance (Cap.486) (“PDPO”) of the Hong Kong Special Administrative Region of the People’s Republic of China (“HKSAR”). We make every effort to ensure that all our employees and Partners observe and comply with this Privacy Policy Statement. 2. Infinitus shall not disclosure or sell any non-public information involving personal data, including but not limited to browsing history and other non-public information you may have stored in the Website, to any third party, save and except:-
 - (a) Infinitus has obtained your consent;
 - (b) For the purpose of complying with the laws of the HKSAR or any other competent jurisdictions; or
 - (c) For the purpose of performing any agreement with you.

II. Collection of Personal Data

1. Infinitus and its agents may collect and keep certain categories of personal data, including the following:-
 - (a) Name;
 - (b) Other information, including e-mail address, telephone number, etc.;

- (c) Enquiries, suggestions, opinions, etc.;
- (d) Your browsing and interaction results and records in the Website; and
- (e) The computer/device operating system and information of the internet service providers.

In order for Infinitus to provide better service to User, Infinitus and its agents shall collect, integrate, analyze and utilize the personal information and/or data when User voluntarily uses the Website and service provided therein and voluntarily provides the same. We use cookies including cookies created by third-party analytics such as Google Analytics and Baidu Tongji. When User accesses to and/or uses the Website and service provided therein, the cookies shall automatically record certain information, including but not limited to, geolocation, demographics, IP address, browser's and operation system's type and version, language, name and model of computer/device and date and time of the computer/device. You may refuse the use of cookies at any time by selecting the appropriate settings on your browser. However, it may affect your use and experience of the Website. By continuing to use the Website, you agree to the use of these cookies, this Privacy Policy Statement and the Terms of Use of the Website. III. Use of Personal Data

1. The personal data that we collect from or provided by you may be used for one or more of the following purposes (and subject to your prior consent (which includes indication of no objection) in certain circumstances):-
 - (a) To publish information related to our products, services, activities, competitions, promotions and projects;
 - (b) To use in publication(s) for non-commercial and commercial purposes;
 - (c) To respond to your queries;
 - (d) To collect statistical data and report for analysis and provide anonymous statistical data and report to internal and external party for analysis (which may involve cross-border data transfer);

 - (f) To assess the quality of the Website provided for further improvement; or
 - (g) To achieve the purpose directly related to any of the purposes described above.

2. We will retain your personal data only for so long as is necessary for fulfilling the purpose for which they were collected. Your personal data will be removed after legally allowed.

 - (a) our Partners;

 - (c) persons or organizations who are bound by our confidentiality agreement; and
 - (d) person(s) or organization(s) to whom we are responsible for disclosing the data pursuant to applicable law.

1. You have the right to access and correct your personal data kept by us. Please also ensure the accuracy of the data you provide to us as it may be used for identity verification.
